As more than 75% of registered adult members who voted on Resolution 2 voted Yes/ e, I declare Resolution 2 is carried.

As more than 75% of registered adult members who voted on Resolution 4 voted Yes/ e, I declare Resolution 4 is carried.

85.13% of valid votes cast on Resolution 5 voted YES/ĀE.

Section 7.8 (b) of the Ng ti Koata Trust deed requires resolutions for ratification or change to the trust deed to be approved by not less than 75% of the adult members who are entitled to vote and actually cast a vote on the resolution. As more than 75% of registered adult members who voted on Resolution 5 voted Yes/ e, I declare Resolution 5 is carried.

The voter return percentage was 29.46%, being 533 votes received from 1,809 eligible electors of which 67.73% voted via the internet and 32.27% voted by post or at the AGM.
